V. REFERENDUM

Be it resolved that the Board of Education approves:

A. Motion of the Middle Township Board of Education:

Upon the recommendation of Steve Siegel, Spiezle Architectural Group, Inc., architects of record for the Board, and after review of the bid submissions, and results of the bid opening on March 30, 2017 for construction projects at Elementary School #2, Shun Pike Property, Middle Township High School and Middle Township Middle School, Spiezle Commission No. 16K014 (the "Project"), and after consultation with the facilities committee of the Board, and counsel, and for good cause, the Administration makes the following recommendation:

1. To reject all bids opened on March 30, 2017 for Contracts #1 and #4 for the Project pursuant to N.J.S.A. 18A:18A-22, for, among other reasons:
 - Said bids substantially exceed the Board's cost estimate or appropriation or budget for the projects; and
 - The board wants to substantially revise the specifications for the good or services; and

- That because of the numerous, un-waivable, and material defects in the bid submissions, the purposes or provisions or both of the Public School Contracts law would be more faithfully adhered to by rejecting the bids and rebidding; and
 - That it is in the public interest for the Board to reject the bids and rebid.
2. To award, consistent with and including but not limited to the notice of bid, bid specifications, bid submission, and contract documents, the following contracts for the bids opened on March 30, 2017 for the Project.
- Contract #2, to MJJ Construction in the amount of \$1,766,000, and which consists of Base bid including Allowances P3-AW1, and P3-AW2, Unit Price submission P3-UP1, as well as alternates P3-ALT1 and P3-ALT2.
 - Contract #3, to MJJ Construction in the amount of \$1,044,000, and which consists of Base bid including Allowances P4-AW1 and P5-AW1.
